The Award recognizes the efforts of non-members in helping members to excel in their contributions to the Chapter and the profession. The Chapter Board knows that special people, who too often go unnoticed, support any success enjoyed by the Chapter or by individual members. This Award gives you the opportunity to nominate such people for this recognition.

ELIGIBILITY

The nominee cannot be a member of APWA.

SELECTION OF RECIPIENT

Upon receipt of nomination forms, The APWA-NC Awards Committee shall determine the eligibility of all Nominees for this award and, may, as its discretion, waive certain requirements for good and sufficient reason. A majority vote of the Committee shall prevail.

TIME AND METHOD OF AWARD

The award shall be made during the Annual Chapter Meeting of the APWA-NC, or at some other appropriate time and place as determined by the Committee, and shall be done with the appropriate dignity and ceremony.
