APWA Government Affairs Committee

The National APWA Government Affairs Committee (GAC) is working hard on behalf of communities all across the country. We understand that no community can exist without public infrastructure. It makes us safe, healthy and able to enjoy the quality of life we have come to expect.

As such, APWA is a committed advocate for our public infrastructure. The GAC and other member advocates are implementing efforts to create partnerships with key stakeholders, establish new lines of communication with policy-makers and extend our outreach into the center of public policy discussions. And we are making an impact. Our advocacy is focused on advancing the interests of all APWA members and the communities we serve. Five principal objectives guide our advocacy efforts and form the basis of our legislative and regulatory priorities and our positions on the issues:

- Support for adequate investment in public infrastructure
- Respect for local authority
- Reasonable regulations and protection from unfunded mandates
- Support for streamlining government oversight
- Support for sustainability and environmental stewardship

During our recent visit to Washington, DC to Storm the Hill, the GAC met with Congressional representatives to discuss five critically important issues requiring immediate attention.

- 1. Support for Surface Transportation Reauthorization
- 2. Implement Streamlined Transportation **Project Review**
- 3. Pass a long-term and adequately funded National Flood Insurance Program
- 4. Wastewater and Drinking Water Infrastructure Funding
- 5. The Farm Bill (limit nutrient run-off)

Even with this progress, we can always use help with our advocacy efforts. You can get involved by joining APWA Advocates. By joining this effort, you will have a direct line of communication with the Congressional representative(s) in Washington represents you. Short Session Preview

Many proposals remain eligible for consideration by the N.C. General Assembly in the 2012 Short Session, which begins tomorrow. This overview by WRAL quotes legislative leaders promising a speedy session that will conclude by July 4. With the focus on state budget adjustments, controversial bills will not likely be considered.

Of top interest to League members, legislators have indicated priority consideration of hot-button local government authority issues of annexation and extra-territorial jurisdiction. The outcome of these discussions will affect the way communities grow and could dictate water and wastewater service areas for many utilities. In addition, legislators will likely vote on a constitutional amendment regarding governments' use of eminent domain, including for public utility purposes.

Other environmental legislation that could receive consideration this session includes the following topics:

Water. Beginning last session and continuing through the interim, the League has worked with a coalition of business and industry interests to advance changes to the state's reclaimed water laws, as well as statutory changes to increase water storage and ensure a smoother interbasin transfer process. Legislators may consider some of these ideas in the Short Session. In addition, the League will follow eligible bills that would prioritize the right of agricultural water withdrawers over the rights of all other water users and would require the interconnection of water and wastewater systems.

Regulatory reform. After overhauling the state's regulatory process last session, legislative leaders have expressed a desire to make further regulatory reforms in the Short Session. The Joint Committee on Regulatory Reform has met periodically throughout the interim period between sessions. Any proposals from this committee would be eligible for consideration in the Short Session.

DENR budget & regional offices. After slashing budget levels for the N.C. Department of Environment and Natural Resources (DENR) in 2011, legislative budget-writers have proposed more modest budget cuts for the next fiscal year. In addition, budget guidelines indicate that funding of the Clean Water Management Trust Fund may become subject to further negotiations, while the required state matching funds for the State Revolving Funds may come from other budget reductions within the DENR budget. Calendars indicate that the House budget bill will be released the first day of session. Legislators will also consider an interim study recommendation against eliminating any DENR regional offices.

Asheville water system. The Metropolitan Sewerage/Water System Committee has recommended that legislators consider a bill in 2013 that would mandate the merger of Asheville's water system with the Metropolitan Sewerage District of Buncombe County. The committee report states that if the governments develop their own plan, "due consideration would be given." The League opposes this proposal and delivered this letter to the committee and Speaker Thom Tillis.

State buffer program. Pursuant to a 2011 legislative directive, DENR produced a report in February regarding the Neuse and Tar-Pam buffer rules. The report examined whether the two sets of buffer rules might be amended or implemented in a different way to achieve the same level of water quality protection while reducing the impact to riparian property owners in the two river basins; and whether to exempt from the rules all single-family residence lots of two acres in size or less platted before the rules became effective. Legislators may consider these proposals in light of the report's recommendations to keep the buffer rules in place.

RETIREE'S CORNER

As time moves on, I find that using the rule of seven helps more and more. Yes, tell me seven times and I'll remember! So, as the General Assembly begins its' 2012 "short session", the word needs to be spread quickly as follows: National Institute on Retirement Security's report clearly indicates 2 very important points that other State and Local entities have already learned. 1) Defined Benefit retirement plans (like we have now) are more cost efficient over Defined Contribution plans due to higher returns and longevity risk pooling, and 2) Defined Contribution plans (most times where the employee must choose their investments, a 401(k) type plan) do not close funding shortfalls, and can actually increase employer costs. Again, we hope the DB/DC issue has been put to rest; however, we must watch out for those who want to chip away at the current plan, thinking only of short term gains in lieu of long term results. As indicated in an earlier article, Local Government decision makers must realize that diminishing retirement security will have significant negative impacts on police officers, firefighters and the many other dedicated employees they have now and want to have, especially in the future.

Requests for the General Assembly to consider include a modification to G.S. 128-28(k) that will clarify the role of the Local Government

Employees Retirement System (LGERS) Board of Trustee's authority to grant COLA's as long as any changes are not inconsistent with the actions of the General Assembly. While this memorializes the way business has been conducted for years and looks rather simple on the surface, it is being requested in anticipation of the Governmental Accounting Standards Board (GASB) making changes that might call for our type of Retirement System to be put into a position of granting automatic COLA's vs. the current method of ad hoc increases, thus creating unfunded long term liabilities. Unfortunately for retirees, last year's efforts to modify the very same section of this statue under Senate bill 538 is not included. You may recall this bill would grant the LGERS Board of Trustees authority to grant COLA's of up to 4% without being tied to the Consumer Price Index. This change would allow the Board to deal better with the 1990's GASB requirement to use the 5 year smoothing rule which when combined with the above referenced 1970's statue sets up a scenario whereby retiree benefits fall behind the Consumer Price Index much faster, and make it impossible for retiree benefits to ever catch up with inflation.

Other issues in this year's Legislative program include the "Protect the Pension Act of 2012". If passed as

written, it will provide whistleblower protection for reporting fraud, provide tools for conducting fraud investigations, provide authority to prevent "salary spiking", make it a crime to keep a disabled decedents benefit and clarify authority for Medical Board appointments.

Lastly, an "un-official" update on the value of the State's Pension program. In the fall of 2007, as the recession started, the Pension Plan had a value of \$77.4 billion. At its low point, February, 2009, the plan's value had dropped to \$54.6 billion! As of December 31, 2011, the value had recovered to \$71.8 billion. And now, I am pleased to report the value as of March 31, 2012 was \$75.9 billion, an increase of \$4.1 billion in three months! While we are within \$1.5 billion of where we were in 2007, we must remember the program is set up to grow by 7.25% per year (including 3% for inflation) just to maintain the actuarial integrity of the plan (no COLA's), so we are still behind, possibly by as much as \$25 billion. We must remember the plan serves some 850,000 with the local system serving 213,000 active and retired servants from 890 employers!!!

Our next Fleet Tour is set for July 18 at the Town of Wake Forest Fleet Department.




New 24/7 Online Library Available July 1
